Downtown Omni Hotel, Austin put on her finest for two days and nights of one of CLD's best conferences in recent history.

Although there will be other places within this issue for thanking various people, I would be remiss if I did not say publicly to all volunteers headed by Local Arrangements Committee chair Kat Pfannenstiel how much you were appreciated. The conference just could not have run so smoothly or been as much fun for those of us who participated or presented without your working behind the scenes, running errands, fixing tiny lastminute glitches. I also want to give a "big Texas shout out" (as my middle school students say) to those persons whose joyful faces represented our organization at the registration table. Thank you to our Board of Trustees members who volunteered to join the Local Arrangements Committee members and greet those who came to the table to pick up registration materials. I was especially appreciative of the enthusiastic Texas CLD representatives led by Texas CLD president Colleen Reutebuch. I must say I wore my flashing state of Texas pin with pride. Finally, there cannot be sufficient thanks for our two conference committee chairs, Diane Bryant and Judy Voress. I know the Board of Trustees joins me in a rousing standing ovation for their tireless work in making this conference one of our best. It pleases me to no end that they will continue as chairs for next year's conference, our 35th, which will again be in Austin on October 24th and 25th, 2013.

Several exciting pieces of business were decided at the recent conference. At our meeting of the Board, your trustees voted to extend *a special level of membership to our retired members* (defined as persons no longer employed by a university, school district, or consulting firm) or individuals wishing to join as retired members at a reduced cost. This addition to membership levels will require a change in our organization Bylaws, which will be voted on by the general membership later this spring.

In other action, the board approved a new *Standing Committee on Professional Development*. This evolved from a Committee on Special Development co-chaired by **Chris Curran** and Leadership Academy Cohort 2 member **Kat Pfannensteil.** The committee members worked very hard during the 2011–2012 year to begin production of a webinar on bullying. Look for information on this webinar going "live" very soon. The new Standing Committee will also require a By-laws change, which will be voted on at the same time as the membership level addition.

In addition, candidates for two positions on our board for 2013 and beyond were presented at the general business meeting during the conference. Voting for secretary and vice president will also take place electronically during the voting window from January 15 to February 1. All candidates are strong, and whoever wins in the election, which will be announced later in spring 2013, will provide sound leadership for our organization going forward. We have an all-volunteer board who spend many hours throughout the year in service to your organization. It is enjoyable but serious work, and I congratulate those who choose to serve. As members of our organization, I hope you will choose to support our organization by voting in this important election. Look in this issue of *LD Forum* for candidate bios and voting information, and watch your email for specific instructions regarding electronic voting!

CLD has many areas on which to focus our efforts. I hope those of you who enjoyed our conference this fall will personally contact someone who attended but who is not yet a member (a number of presenters fell into that category). 34th International Conference on Learning Disabilities

On October 10th and 11th, the

Council for Learning Disabilities held its 34th International Conference in Austin, Texas. On Wednesday,

CLD President Caroline Kethley presented Steve Graham with the J. Lee Wiederholt Distinguished Lecturer Award. Dr. Graham delivered the keynote address, Evidence-based Practices for Teaching Writing to Students with Learning Disabilities. Following the keynote,

conference attendees were able to attend a variety of presentations centering on the 2012 conference theme, *Learning Disabilities: Looking Back and Looking Forward–Using What We Know to Create a Blueprint for the Future.*

A variety of presentations on research interventions, teacher preparation, and policies focused on improving outcomes for students with LD followed the keynote address. Conference attendees had the opportunity to learn more about current research methodologies as well as measures to improve those methodologies, academic and behavioral interventions, and policy updates.

The **President's Reception and interactive poster session** included 52 presenters. Thursday morning sessions offered a variety of exciting presentations. **Deborah Reed, Caroline Kethley, Beverley Weiser, Ed Shapiro,** and **Kelli Cummings** presented **MUST READS**, a session highlighting articles published during the last year that are considered essential to the learning disabilities field. Each year the MUST READS are published in *Learning Disabilities Quarterly*. Be sure to check out the 2011 MUST READS in the November 2012 LDQ issue.

In addition to informative conference sessions, CLD was proud to announce the **CLD Teacher of the** Year award winners: Arlene Vigil-Olech, Colorado Chapter; Kathy Steinmetz, Minnesota Chapter; and **Margaret Delgado, Texas Chapter.** Arlene, a special education teacher and coach, was described as a having a high energy level and drive, and an ability to "teach the most reluctant learner." Like Arlene, Kathy is a leader and mentor in her department. Kathy chairs the Parent Involvement Committee. Margaret serves as a reading intervention specialist who is also highly involved in her community through her volunteer work on behalf of Special Olympics. We commend these educators for their service to our students with LD, their families, and the community.

Pati Montgomery and Melody Ilk, Colorado CLD Chapter, were honored with the Floyd G. Hudson Award. This award is given for outstanding performance and commitment by a professional who works in the field of learning disabilities in a role outside of the classroom. An elementary school principal, Pati was the first in her district to bring scientifically based reading strategies into practice. Melody, a literacy coordinator, works diligently to develop high quality literacy professional development programs. Both Pati and Melody have worked collaboratively to significantly decrease the number of students' experiencing reading failure.

CLD wishes to thank **Diane Pedrotty Bryant** and **Judy Voress**, who served as conference chairs, and the members of the Texas Local Arrangement Committee—Kathleen Pfannenstiel, Chair; Heather Haynes; **Mikyung Kim**; and Colleen Reutebuch—for their hard work and hospitality.

Candidates

Diane Bryant, PhD

I am a professor of special education at The University of Texas at Austin, a Fellow in the Audrey Rogers Myers Centennial Professorship in Education, and project director for the Mathematics Institute for Learning Disabilities and Difficulties in The Meadows Center for Preventing Educational Risk. Currently, I serve as the principal investigator on an algebra-

readiness intervention grant from the Institute of Education Sciences and as co-editor of the journal *Learning Disability Quarterly*.

I have been an active member in CLD for many years, having served in leadership positions at both the state chapter and national levels. My service at the national level includes president of the organization and chair of the Leadership Development and Research committees. I have been involved in CLD conferences as a presenter and now as the co-chair of the retooled Conference Committee. Inspired by the success of the newly formed Leadership Academy, which supports early career professionals, and the exciting work of the new Professional Development Committee, I am seeking election as vice president. I believe there is much work to be done to promote the organization and would like to be a part of this to help make a further contribution, along with my colleagues,

to CLD.

Tandra Tyler-Wood, PhD

I am a professor in the Department of Learning Technologies at the University of North Texas. I have coordinated budgets for college departments and six large federal grants with budgets of more than



\$1 million. After serving as parliamentarian for three years, I would like to serve as vice president of the Council for Learning Disabilities.

I strongly support CLD's recent initiatives to get our message out to schools, teacher training institutions, and the general public. We are providing expertise on critical topics, such as bullying, through our webinars. I would like to see our organization explore other opportunities for using technology to spread our message. I believe that the future of our organization rests with our younger members. CLD should provide a home where our younger generation can receive the mentoring and career support they need to become the future leaders of not just CLD but of a universal learning community. I strongly support our recent initiatives to provide mentors for younger members and believe the program should be continued and expanded. The Secretary serves a 2-year term.
